Recommendation of the Transfer Committee for intra region transfer / Posting of Non-Medical Staff in the cadre of Assistant, UDC, LDC and MTS for Annual General Transfer within the Region (Intra Region) for the Transfer Year – 2025

As constituted by the competent Authority vide Sub Regional Office, Kozhikode Circular dated 14.05.2025, the Transfer Committee (TC), consisting of the following officers discussed in detail the instructions given in the Transfer Policy (TP) for Transfer/Posting of Non-Medical Staff in the Cadre of Assistant, Upper Division Clerk, Lower Division Clerk and MTS posted under SRO Kozhikode for Annual General Transfer for the Transfer year 2025:-

The Transfer Committee received a total of 32 cases of which 26 cases are with options, 04 cases are transferred in from other regions and 02 cases are without option (as they have completed more than 05 years in an office).

The Transfer Committee decided to consider only those cases which require a mandatory transfer adherence to the guidelines given in the transfer policy (TP), as per clause 4.2 and 4.3, as the academic year for 2025-26 have already commenced so that the staff faces minimum disturbance. In adherence to the guidelines given in the transfer policy (TP), the committee submits its recommendations in Annexure-I for Assistant Cadre, Annexure-II for UDC cadre and Annexure-III for LDC Cadre

The transfer committee, upon reviewing the average daily benefit payments and Accident Reports of each branch office, further recommends that, one staff from BO Kozhikode, Kannur and Feroke may be brought to SRO Kozhikode and one staff may be posted at BO Malappuram (above the sanctioned strength, if found necessary).
